**December 2025 was a Neutral market!** The number of for sale listings was up **16.7%** from one year earlier and up **16.7%** from the previous month. The number of sold listings decreased **50%** year over year and increased **300%** month over month. The number of under contract listings was down **85.7%** compared to previous month and down **75%** compared to previous year. The Months of Inventory based on Closed Sales was 3.5, up **133.3%** from the previous year.

The Average Sold Price per Square Footage was 0. The Median Sold Price increased by **23%** from last month. The Average Sold Price also increased by **19.8%** from last month. Based on the 6 month trend, the Average Sold Price trend was "Neutral" and the Median Sold Price trend was "Neutral".

The Average Days on Market showed a neutral trend, an increase of **163.6%** compared to previous year. The ratio of Sold Price vs. Original List Price was 96%, a decrease of **2%** compared to previous year.



### It was a Neutral Market

#### Property Sales (Sold)

December property sales were 4, down **50%** from 8 in December of 2024 and **300%** higher than the 1 sales last month.

#### Current Inventory (For Sale)

Versus last year, the total number of properties available this month was higher by 2 units of **16.7%**. This year's bigger inventory means that buyers who waited to buy may have bigger selection to choose from. The number of current inventory was up **16.7%** compared to the previous month.

#### Property Under Contract (Pending)

There was a decrease of **85.7%** in the pending properties in December, with 1 properties versus 7 last month. This month's pending property sales were **75%** lower than at this time last year.

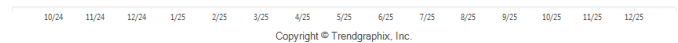

### The Average Sold Price per Square Footage was Neutral\*

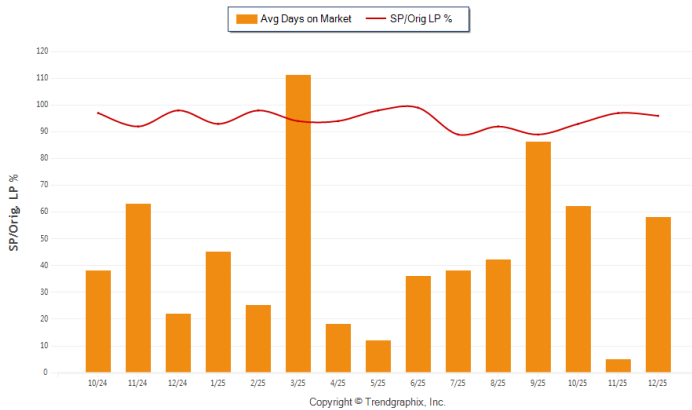

Since Median Sold Price and Average Sold Price can be impacted by the 'mix' of high or low end properties in the market, the Average Sold Price per Square Footage is a more normalized indicator on the direction of property values. ### The Days on Market Showed Neutral Trend\*

The average Days on Market (DOM) shows how many days the average property is on the market before it sells. An upward trend in DOM trends to indicate a move towards more of a Buyer's market, a downward trend indicates a move towards more of a Seller's market. The DOM for December 2025 was 58, up **1,060%** from 5 days last month and up **163.6%** from 22 days in December of last year.

### The Sold/Original List Price Ratio Remains Steady\*\*

The Sold Price vs. Original List Price reveals the average amount that sellers are agreeing to come down from their original list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. This month Sold Price vs. Original List Price of 96% was down **1%** % from last month and down from **2%** % in December of last year.

### The Average For Sale Price was Neutral\*

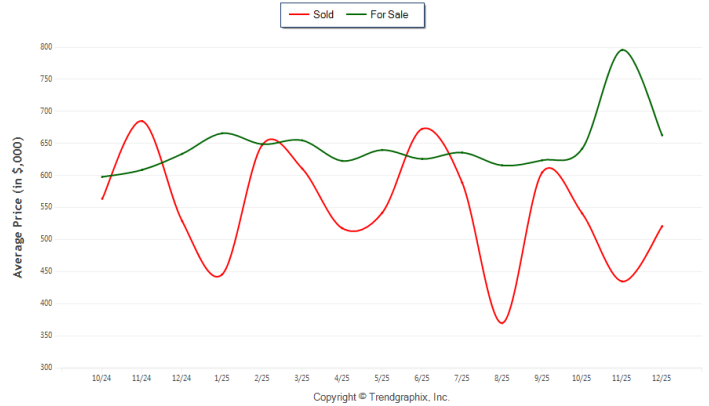
The Average For Sale Price in December was \$663,000, up **4.6%** from \$634,000 in December of 2024 and down **16.7%** from \$796,000 last month.

### The Average Sold Price was Neutral\*

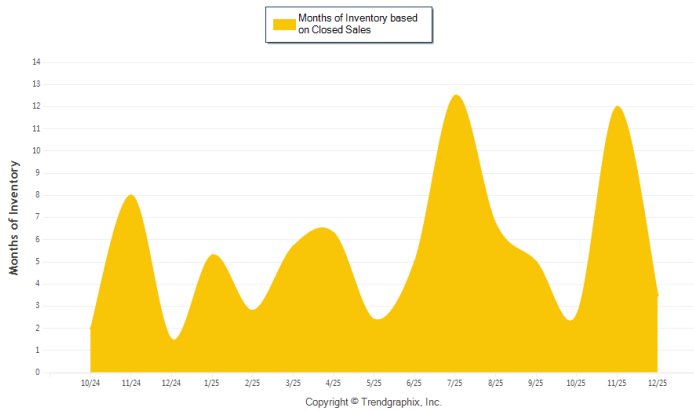
The Average Sold Price in December was \$521,000, down **1.5%** from \$529,000 in December of 2024 and up **19.8%** from \$435,000 last month.

### It was a Neutral Market\*

A comparatively lower Months of Inventory is more beneficial for sellers while a higher months of inventory is better for buyers.

\*Buyer's market: more than 6 months of inventory

 Neutral market: 3 – 6 months of inventory

### **Months of Inventory based on Closed Sales**

The December 2025 Months of Inventory based on Closed Sales of 3.5 was increased by **133.3%** compared to last year and down **70.8%** compared to last month. December 2025 was Neutral market.

### **Months of Inventory based on Pended Sales**

The December 2025 Months of Inventory based on Pended Sales of 14 was increased by **366.7%** compared to last year and up **717.5%** compared to last month. December 2025 was Buyer's market.

Absorption Rate measures the inverse of Months of Inventory and represents how much of the current active listings (as a percentage) are being absorbed each month.

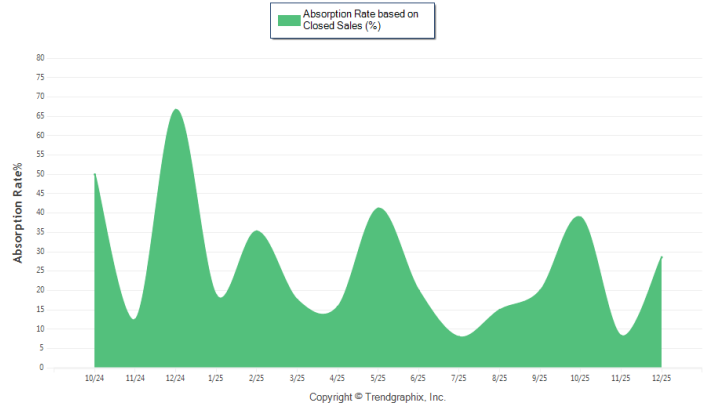
\*Buyer's market: 16.67% and below
